# Market Context & Challenges

Africa suffers more than its fair share of communicable and non-communicable diseases. It also has the lowest production capacity for health products in the world. African countries currently import more than 79%<sup>1</sup> of their pharmaceutical supply from outside the continent. This dependency is unsustainable – particularly in the face of the expected population growth.

The COVID-19 pandemic has further **exposed Africa's vulnerabilities** in ensuring access to essential medicines, vaccines, and other medical products. Increasingly, African governments view the **availability of safe, effective and affordable medicines and vaccines** as a **national security issue**. Strenthening regional value chains will **save lives, improve public health** and boost African economies, including **supporting local jobs**.

# **The Opportunity**

The African Union Development Agency New Partnership for Africa's Development (AUDA – NEPAD), Unitaid and World Health Organization's (WHO) Local Production and Assistance Unit jointly conceptualized the **Health Products Manufacturing Support Platform** (HMSP). The HMSP will address the challenge of technical capacity for regional manufacturers in Africa by **matching opportunities for technical assistance** related to technology, management, and operational skills, specific projects and skill sets, linkages to capital, and regulatory compliance.

The HMSP aims to fill the identified capability gaps on the African continent **along the health products manufacturing value chain**. This will be achieved by **leveraging a coordination platform to facilitate assistance engagements** that will increase the capacity and capabilities of participating African manufacturers and other relevant actors. The HMSP will serve as one of the mechanisms for the operationalization of the Pharmaceutical Manufacturing Plan for Africa (PMPA) in alignment with the mandate of the AUDA – NEPAD. The WHO Local Production Unit and Unitaid will serve as partners to AUDA – NEPAD in the execution of the HMSP.
